

The brand of Minted of gold is Istanbul Gold Refinery (IGR)

The proposed Terms and Conditions for IGR Minted Gold:

- 1. Purchases of Minted Gold are subject to availability and current gold market prices.
- 2. Prices of Minted Gold are based on live gold prices and a premium, which may fluctuate from time to time.
- 3. Payments for Minted Gold must be made via FPX.
- 4. Minted Gold is available in denominations of 0.5 gram, 1 gram, 2.5 gram, 5 gram, 10 gram, 1 dinar, 5 dinar, 50 gram, and 100 gram.
- 5. The delivery fee for Minted Gold is RM15 (inclusive of insurance) per delivery address.
- 6. Delivery times for Minted Gold are estimated at 3-5 days for West Malaysia and 5-7 days for East Malaysia.
- 7. Customers who wish to request a refund must contact customer service.
- 8. The refund policy for Minted Gold is subject to change without notice.
- 9. The condition regarding when customers are eligible to request a refund:
- 10. Customers may request a refund for Minted Gold under the following conditions:
  - a) The Minted Gold is defective, damaged, or not as described.
  - b) The customer receives an incorrect order or an order that was not processed in accordance with their instructions.
  - c) The customer cancels the order before it is shipped.
  - d) The customer is not satisfied with the quality of the Minted Gold.
- 11. Minted Gold that has been opened, used, or altered in any way may not be eligible for a refund. Customers who are unsure whether their Minted Gold is eligible for a refund are advised to contact customer service for assistance.
- 12. Refund requests must be made within **7 days** of receipt of the Minted Gold. Refunds will not be processed for any request made after this period.
- 13. All requests for refunds must be made by contacting customer service. Refunds will not be processed for any request made through other channels, such as social media or third-party websites.
- 14. The refund policy for Minted Gold is subject to change without notice.
- 15. Customers are advised to carefully review the refund policy before making a purchase of Minted Gold. Any questions or concerns regarding the refund policy should be directed to customer service.
- 16. Refunds for Minted Gold are subject to the following conditions:
  - a) Customers must contact customer service within 7 days of receipt of Minted Gold to initiate a refund request.

  - d) Refunds will be processed within 14 days of receipt of the returned Minted Gold.
  - e) Refunds will be issued to the original payment method used for the purchase of Minted Gold.





- f) Any shipping fees or other charges incurred by the customer in connection with the purchase of Minted Gold will not be refunded.
- g) The refund amount will be based on the current gold market price at the time of receipt of the returned Minted Gold, less any applicable fees and charges.
